**RESOLUTION NO. 113, SERIES OF 2014**

**“A RESOLUTION ENACTING AN ORDINANCE DECLARING AS ECONOMIC ENTERPRISES OF PILAR, SORSOGON OUR PORT, MARKET, SLAUGHTERHOUSE AND TERMINAL.”**

**WHEREAS**, among the sources of revenue of our Local Government Unit are the Port, Market, Slaughterhouse and Terminal;

**WHEREAS**, these are the major local sources of income of our Local Government and there is a need to declare the same as LGU-Pilar’s Economic Enterprise by way of an ordinance;

**WHEREFORE**, premises considered, on motion of Hon. Hon. Arthur John S. Garchitorena seconded by All the Members present in session, it was

**RESOLVED**, to approve Municipal Ordinance No. 004, Series of 2014 **declaring as economic enterprises of pilar sorsogon our port, market, slaughterhouse and terminal.**

**MUNICIPAL ORDINANCE NO. 004, SERIES OF 2014**

**“AN ORDINANCE DECLARING AS ECONOMIC ENTERPRISES OF PILAR SORSOGON OUR PORT, MARKET, SLAUGHTERHOUSE AND TERMINAL”**

Be it enacted by the Sangguniang Bayan of Pilar, Sorsogon, that:

Section 1. **Short Title.** This ordinance entitled “**AN ORDINANCE DECLARING AS ECONOMIC ENTERPRISES OF PILAR SORSOGON OUR PORT, MARKET, SLAUGHTERHOUSE AND TERMINAL**” shall have a short title of **PILAR ECONOMIC ENTERPRISE ORDINANCE.**

Section 2. **Policy.** It is the policy of the Local Government Unit of Pilar to create economic enterprise that will boost the fiscal status of our municipality.

Section 3. **Declaration.** The Port, Market, Slaughterhouse and Terminal operated and maintained by our Local Government Unit are hereby declared as the Economic Enterprise of the Local Government Unit of Pilar, Sorsogon, Pilar, Sorsogon.

Section 4. **Effectivity.** This ordinance shall take effect Fifteen (15) days following its approval and posting in at least two conspicuous places in the municipality.
